A roll of adhesive covered sheets wound adhesive-side out without a paperboard core that are used to remove lint and pet hair. The individual sheets are separated by perforations. When the outer surface of the roll is filled with debris, the outer sheet can be peeled away, torn off the roll, and discarded. This leaves a clean surface on the roll. A cover wrap is provided that may be replaced on the adhesive surface when not in use. Designed to be used with 3M<sup>TM</sup> Lint Roller Handles.
